Any capitalized term used but not defined herein shall have the meaning ascribed to it in the Agreement. Agency and Participant agree to amend the Agreement by incorporating the following "Consent to Contact" into the Agreement, as set forth below:

Consent to Contact:

Notwithstanding any current or prior election to opt in or opt out of receiving calls or SMS messages (including text messages) from SCRAM Systems, its agents, representatives, affiliates, or anyone calling on SCRAM System's behalf (hereafter referred to as "Representatives"), I expressly consent to be contacted by SCRAM Systems, and its "Representatives" for any and all purposes arising out of or relating to the Program, at any telephone number, or physical or electronic address I provide or at which I may be reached. **I agree SCRAM Systems may contact me in any way, including SMS messages (including text messages), calls using prerecorded messages or artificial voice, and calls and messages delivered using an automatic telephone dialing system (an "auto-dialer") or an automatic texting system.** Initial Here _____

I also agree to add the SCRAM Systems Monitoring Center telephone number of **855-697-0515** to the list of "known contacts" in my telephone directory to facilitate delivery of said calls. Automated messages may be played when the telephone is answered whether by me or someone else. In the event that a Representative calls, the Representative may also leave a message on my answering machine, voice mail, or send a message via text. Initial Here _____

I consent to receive SMS messages (including text messages), calls and messages (including prerecorded and artificial voice and auto-dialed) from SCRAM Systems and its Representatives at the specific number(s) I have provided to SCRAM Systems, or numbers SCRAM Systems can reasonably associate with my Program account (through skip trace, caller ID capture, or other means), with information or questions regarding the Program or any Device I have been issued in connection with the Program. I certify, warrant, and represent that the telephone numbers I have provided to SCRAM Systems are my contact numbers. I represent that I am permitted to receive calls at each of the telephone numbers I have provided to SCRAM Systems. I agree to promptly alert SCRAM Systems whenever I stop using a particular telephone number. I acknowledge that my cellular or mobile telephone provider may charge me according to the type of plan I carry. I agree that there is no limit to the number of times that SCRAM Systems may contact me pursuant to the foregoing. Initial Here _____

I also agree that SCRAM Systems may contact me by e-mail, using any email address I have provided to SCRAM Systems or that I provide to SCRAM Systems in the future. SCRAM Systems may listen to and record phone calls between me and SCRAM Systems Representatives without notice to me as permitted by applicable law.
